PRODUCT OPERATION

FEATURES

Filtration—The filtration system is used to filter the water.

Convenience—The bar cart has a stainless steel sink and faucet. It has a drain, towel rack, front-locking commercial-type casters, fold-down removable side preparation shelves, and a bottle opener with a cap catcher.

Storage—The bar cart has an ice bin compartment with a sliding cover, a 4-section compartment/bottle bin, and on portable models, a storage cabinet.


Excessive Weight Hazard

Use two or more people to move and install bar cart.

Failure to do so can result in back or other injury.

Use a certified plumber to connect and install potable water supply and drain system to outdoor bar cart per local code requirements.

Water from the water fill line is routed through an AquaSense™ water filter before going to the faucet. The filter is located below the bar cart for easy replacement.



All tubing connections to the filter and hard connections are John Guest fittings.

Drains are provided at the sink and the ice storage bin, which are routed through holes at the rear of the cart.


REMOVING THE FAUCET

1. Remove the rear panel from the cart.

2. Disconnect the filter water line tubing from the faucet connector.
3. Remove the faucet connector from the faucet.

Filter Tubing


4. Remove the nut from the faucet and remove the faucet from the unit.

1. Open the door.
2. Lift the door straight up so the hinge pins slide out of the hinge hangers.




PORTABLE & BUILT-IN MODELS

The portable model must have suitable drain systems in accordance with local codes for the ice bin and sink drains.




BUILT-IN INSTALLATION
